<b>KAOLIN</b>	No significant acute toxicological data identified in literature search. For bentonite clays: Bentonite (CAS No. 1302-78-9) consists of a group of clays formed by crystallization of vitreous volcanic ashes that were deposited in water. The expected acute oral toxicity of bentonite in humans is very low.
<b>CALCIUM CARBONATE</b>	The material may produce severe irritation to the eye causing pronounced inflammation. Repeated or prolonged exposure to irritants may produce conjunctivitis. <b>C.I. PIGMENT RED 3</b>	Detailed analysis of molecular structure indicates that the azo colourant can split off cancer-causing arylamines. The azo linkage, a double bond between two nitrogen atoms, is considered the most unstable part of an azo dye. The substance is classified by IARC as Group 3: <b>NOT</b> classifiable as to its carcinogenicity to humans. Evidence of carcinogenicity may be inadequate or limited in animal testing. Bacterial mutagen Subchronic or Prechronic Exposure: Treatment of F344 rats and B6C3F1 mice with C.I. Pigment Red 3 in the diet (10, 5.0, 2.5, 1.25, 0.6 or 0.3%) for 14 and 90 days resulted in haematological alterations consistent with haemolytic anemia. Long-term dietary administration resulted in the development of tumours of the liver, skin, adrenals and Zymbal gland in rats and kidney and thyroid tumors in mice. An Ames bacterial test has given evidence of weak mutagenicity, but no chromosome effects were seen in mammalian cells in culture.[ Under the conditions of a 2 yr feed study, there was some evidence of carcinogenic activity of C.I. Pigment Red 3 in male F344/N rats as exhibited by increased incidences of benign pheochromocytomas of the adrenal gland.
