## **Lacquer Sanding Sealer - F822 Series**

#### **Product Description**

Lacquer based pre-finish that dries crystal clear. It will dry fast and is extremely durable as a first coat on unfinished wood surfaces.

#### **Recommended Use**

First coat for new or stained interior wood surfaces such as doors, cabinets, paneling, and other wood trim. It dries fast, and provides a crystal clear finish.

## **General Surface Preparation**

The surface must be free of wax, dust, grease, oil, dirt and any old finish, and must be totally dry. Use a chemical stripper to remove and strip old finishes.

Sand wood smooth and remove any dust with a vacuum or a clean rag dampened with mineral spirits

### **Application**

Brush, paint pad or spray.

#### Clean up

Clean tools and equipment with naptha. Do not use water on natural bristle or china bristle brushes.
