Fix-Rite Interior/Exterior Latex Paint Flat - F514 Series

Product Description

Fix-Rite Latex Flat is a multi-purpose, durable, flat coating for both interior and exterior use. Fixall Fix-Rite Latex Flat may be used on wood, drywall, plaster, masonry, stucco and primed metal. It is high hiding, easy to apply, and cleans up after use with soap and water. Fixall Fix-Rite Latex Flat dries in less than one hour to a non-yellowing, non-chalking and blister resistant finish.

Recommended Use

For use on wood, drywall, plaster, masonry, stucco and primed metal.

General Surface Preparation

Surface must be dry and free of grease, wax, dirt, mildew and other foreign matter. Spackle, caulk or fill all voids. Scrape off all loose paint and dull the gloss on enameled and varnished surfaces by sanding. Vacuum or dust surface with clean rag after sanding.

Previously Painted Surfaces: LATEX FLAT can be applied directly to properly prepared previously painted surfaces as long as the old paint is adhering well and in sound condition. Spot prime bare areas with an appropriate primer.

Galvanized Metal should be properly prepared prior to coating.

Application

Fix Rite is designed to be applied with a good quality paint applicator. Apply one or two coats to a properly prepared surface. Flow the paint on liberally to assure good hiding and lasting protection. As with all paints, intermix cans of the color to ensure color uniformity. Try to stop at corners or turns to avoid lap marks. Paint only when surface is above 50° F.

Clean up

A mixture of warm water and mild soap is the best cleaning solution for water-based paints. Prepare soapy water and pour into a clean container. Dip the paint brush into the mixture, working the soap through the brush bristles. Follow with a clear water rinse. Repeat the process if necessary. Always use a clean container with clean soapy water and follow with a clear water rinse. For stubborn water-based paints, try mineral spirits or lacquer thinner, followed by warm soapy water and a clear water rinse.
